STUDY DESCRIPTION

THE NEW HAVEN COMMUNITY STUDY WAS CONDUCTED BY ROBERT A. DAHL AND WILLIAM FLANIGAN IN THE SUMMER OF 1959. THE QUESTIONNAIRE CONTAINS BOTH CLOSED AND OPEN-ENDED QUESTIONS DESIGNED TO ASCERTAIN THE POLITICAL ATTITUDES, BEHAVIOR AND INFLUENCE OF THE ACTIVE ELECTORATE OF NEW HAVEN, CONNECTICUT, ON A LOCAL LEVEL. IT INCLUDES QUESTIONS ABOUT EACH RESPONDENT'S LOCAL POLITICAL CONCERNS, LEVEL OF POLITICAL INTEREST, POLITICAL AWARENESS, POLITICAL ACTIVITY, RESPECT FOR POLITICAL AND GOVERNMENT OCCUPATIONS, PARTY PREFERENCE, VOTING BEHAVIOR, GROUP AFFILIATION, REACTION TO THE MAJOR LOCAL ISSUES, AND SOME ETHNIC, SOCIO-ECONOMIC AND OTHER PERSONAL DATA.

RESULTS OF THE NEW HAVEN COMMUNITY STUDY ARE DISCUSSED IN ROBERT A. DAHL, WHO GOVERNS?, (NEW HAVEN AND LONDON: YALE UNIVERSITY PRESS, 1961).

SAMPLING INFORMATION

THE INDIVIDUALS INTERVIEWED WERE DRAWN FROM THE NEW HAVEN VOTER REGISTRATION LISTS USED IN THE 1958 ELECTION, AS REVISED THROUGH JUNE OF 1959. FROM EACH WARD LIST, RESPONDENTS WERE DRAWN AT REGULAR INTERVALS AFTER A RANDOM START, IN PROPORTION TO THE TOTAL SAMPLE AS THAT WARD BORE TO THE TOTAL NUMBER OF REGISTERED VOTERS IN THE CITY, THUS INTENTIONALLY UNDERREPRESENTING ADULT NON-VOTERS. IN THE CASES WHEREIN THE PEOPLE SO SELECTED WERE DECEASED OR WERE NO LONGER RESIDENTS OF NEW HAVEN, REPLACEMENTS WERE SELECTED FROM THE SAME WARD.

THE RESULTING SAMPLE CONSISTED OF 818 REGISTERED NEW HAVEN VOTERS, OF WHOM 525 WERE SUCCESSFULLY INTERVIEWED. THE INVESTIGATORS INDICATE THAT THE GROUP NOT INTERVIEWED DOES NOT APPEAR TO DIFFER SIGNIFICANTLY ALONG SEVERAL MAJOR DIMENSIONS FROM THE GROUP INTERVIEWED, SO THAT EVEN THOUGH THE NON-RESPONSE RATE IS UNUSUALLY HIGH, OWING MOSTLY TO VACATIONS AND ILLNESS, THE REDUCED SAMPLE APPEARS TO BE QUITE REPRESENTATIVE OF THE WHOLE.

PROCESSING INFORMATION

THE STUDY WAS PROCESSED ACCORDING TO ICPR STANDARD PROCESSING PROCEDURES; THE CODE CATEGORIES WERE RECODED TO ELIMINATE AMPS AND DASHES AND TO CONFORM TO ICPR STANDARDIZED CODES WHERE APPLICABLE, AND THE DATA WERE CHECKED FOR INCONSISTENT AND ILLEGAL CODES. THESE WERE EITHER CORRECTED OR ASSIGNED TO THE MISSING DATA CATEGORY OF NOT ASCERTAINED, CODED 9 OR 99.

IN USING THIS CODEBOOK, SEVERAL FEATURES SHOULD BE NOTED. THE FIRST IS THAT, ALTHOUGH (IN ACCORDANCE WITH ICPR CUSTOM) THE ORDER OF THE QUESTIONNAIRE WAS PRESERVED IN THE CODEBOOK, CERTAIN ITEMS HAVE BEEN LEFT OUT ENTIRELY, AS THEY NEITHER APPEARED IN THE ORIGINAL CODEBOOK NOR IN THE ORIGINAL DATA RECEIVED FROM THE INVESTIGATORS. ANOTHER IS THAT IN MANY CASES, BOTH IN THE BODY OF THE CODEBOOK AND IN THE FOOTNOTES, TEXT IS BRACKETED IN < AND > SIGNS. ALL TEXT SO BRACKETED WAS NOT CONTAINED IN THE ORIGINAL CODEBOOK BUT WAS ADDED BY THE PROCESSOR, EITHER FOR EXPLANATORY PURPOSES OR IN ORDER TO MAKE VARIABLES INDEPENDENT OF ONE ANOTHER BY MAKING IT UNNECESSARY TO REFER TO ONE IN ORDER TO UNDERSTAND THE TEXT OF ANOTHER. VARIABLE NAMES IN THE TABLE OF CONTENTS FOLLOWED BY AN ASTERISK HAVE SPECIAL ICPR STANDARDIZED CODES. THOSE PRECEDED BY AN X DESIGNATE A VARIABLE DEPENDENT ON SOME OTHER VARIABLE, DUE TO THE STRUCTURE OF THE INTERVIEW SCHEDULE.

CODEBOOK INFORMATION

THE EXAMPLE BELOW IS A REPRODUCTION (NOT ACTUAL SIZE) OF INFORMATION APPEARING IN THE MACHINE-READABLE CODEBOOK FOR A

TYPICAL VARIABLE. THE NUMBERS IN CIRCLES DO NOT APPEAR IN THE CODEBOOK, BUT ARE REFERENCES TO THE DESCRIPTIONS WHICH FOLLOW THIS EXAMPLE.

1. INDICATES THE VARIABLE AND REFERENCE NUMBERS. A VARIABLE AND A REFERENCE NUMBER ARE ASSIGNED TO EACH ITEM IN THE DATA BE SUBSETTED OR REARRANGED BY AN OSIRIS PROGRAM (E.G., MMP2 TO INTERSPERSE DATA FROM ANOTHER SOURCE, OR TCOT2 TO PRODUCE AN ANALYSIS DECK), THE VARIABLE NUMBERS WOULD CHANGE TO REFLECT THE ORDER OF THE NEW DATASET, WHILE THE REFERENCE NUMBERS WOULD REMAIN UNCHANGED TO REFLECT THE VARIABLE NUMBER IN THE CODEBOOK DESCRIBING THE ARCHIVED DATASET.
2. INDICATES THE FOUR COLUMN ICPR STUDY IDENTIFICATION NUMBER UNIQUE TO THIS DATASET.
3. INDICATES THE ABBREVIATED (24 CHARACTERS MAXIMUM) VARIABLE NAME USED WITHIN THE OSIRIS SYSTEM TO IDENTIFY THE VARIABLE FOR THE USER. AN EXPANDED VERSION OF THESE NAMES CAN BE FOUND IN THE TABLE OF CONTENTS.
4. INDICATES THE DESIGNATION OF MISSING DATA. IN THIS EXAMPLE CODE VALUES EQUAL TO ZERO AND THOSE GREATER THAN OR EQUAL TO SEVEN ARE MISSING DATA (MD=0 OR GE 7). ALTERNATIVE STATEMENTS FOR OTHER VARIABLES ARE OF THE FORM "MD=0", "MD=GE 8", OR "NO MISSING DATA CODES". SOME ANALYSIS SOFTWARE PACKAGES (INCLUDING THE ICPR-SUPPORTED PACKAGE) REQUIRE THAT CERTAIN TYPES OF DATA WHICH THE USER DESIRES TO EXCLUDE FROM ANALYSIS BE DESIGNATED AS "MISSING DATA", E.G., INAPPROPRIATE, UNASCERTAINED, UNASCERTAINABLE OR AMBIGUOUS DATA CATEGORIES. ALTHOUGH THESE CATEGORIES ARE DEFINED AS MISSING DATA CATEGORIES, THIS DOES NOT MEAN THAT A USER SHOULD NOT OR CANNOT USE THESE CODES IN A SUBSTANTIVE ROLE IF HE SO DESIRES.

5. A MULTIPLE RESPONSE VARIABLE IS DENOTED BY THE MESSAGE, "MULT RESPS X", WHERE X IS THE NUMBER OF RESPONSES.
6. INDICATES THE STARTING LOCATION AND WIDTH OF THIS VARIABLE WHEN THE DATA ARE STORED ON A MAGNETIC TAPE IN THE OSIRIS FORMAT.
7. INDICATES THE LOCATION BY DECK AND COLUMN(S) OF THIS VARIABLE WHEN THE DATA ARE ON CARDS OR IN CARD IMAGE FORM (EITHER 80 OR 84 COLUMN FORMAT)
8. A VARIABLE CONTAINING DATA WITH IMPLIED DECIMALS IS DENOTED BY THE MESSAGE "XX DEC PLACE(S)", WHERE XX IS THE NUMBER OF DECIMAL PLACES IMPLIED (NOT PUNCHED) IN THE VARIABLE.
9. INDICATES THE FULL TEXT (QUESTION) SUPPLIED BY THE INVESTIGATOR TO DESCRIBE THE VARIABLE.
10. INDICATES AN ADDITIONAL COMMENT OR EXPLANATION APPENDED TO THE VARIABLE DESCRIPTION.
11. A VARIABLE WHICH HAS A FOOTNOTE ASSOCIATED WITH IT IS DENOTED BY THE MESSAGE, "SEE NOTE(S) X", WHERE X IS THE NUMBER OF THE FOOTNOTE REFERENCED.
12. INDICATES THE FREQUENCY OF OCCURRENCE OF EACH CODE VALUE. FREQUENCIES FOR MULTIPLE RESPONSE VARIABLES ARE CUMULATIVE.
