Accompanying the federal election of Germany in 1976, the primary investigators Manfred Berger, Wolfgang G. Gibowski, Edelgard Gruber, Dieter Roth and Wolfgang Schulte (Forschungsgruppe WAHLEN e.V. Mannheim) in collaboration with Max Kaase, Hans D. Klingemann (ZUMA Mannheim) and Uwe Schleth (University of Heidelberg) carried out the study 'Election Study 1976'. The panel comprised two pre-electoral and one post-electoral wave. The panel covers judgements on parties and politicians, satisfaction with government as well as the existing party system and evaluation of the election campaign. They are part of the group 'German Election studies 1949-2009' in the Data Catalogue of the GESIS Data Archive for the Social Sciences.

The following correspondence list gives an overview on the variables and when they were asked, because a large part of identical questions were posed in the three different waves.

In the first column, you find the variable label, which is consistent over the three waves. In the following columns, the variable name and the question number is listed.
