Between January, 28th and March, 12th 1996, INRA (EUROPE), a European Network of Market- and Public Opinion Research agencies, carried out wave 44.2bis of the STANDARD EUROBAROMETER, also called MEGA-survey, on request of the EUROPEAN COMMISSION.

This EUROBAROMETER 44.2bis covers the population of the respective nationality of the European Union membercountries, aged 15 years and over, resident in each of the Member States. The basic sample design applied in all Member States is a multi-stage, random (probability) one. In each EU country, a number of sampling points was drawn with probability proportional to population size (for a total coverage of the country) and to population density. Next to this basic sample an oversample of people working in the sector of agriculture, fishery or forestry was carried out. A minimum number of such interviews per region was imposed.

For drawing the basic sample, sampling points were drawn systematically from all "administrative regional units", after stratification by individual unit and type of area. They thus represent the whole territory of the Member States according to the EUROSTAT-NUTS II (or equivalent) and according to the distribution of the resident population of the respective EU-nationalities in terms of metropolitan, urban and rural areas. In each of the selected sampling points, a starting address was drawn, at random. Further addresses were selected as every Nth address by standard random route procedures, from the initial address. In each household, the respondent was drawn, at random. All interviews were face-to-face in people's home and in the appropriate national language. For weighting and analysis these BASIC regional units were combined in NUTS I areas or equivalent in order to obtain a minimum of 200 cases per region. A list these 95 COMBINED regions is attached.

As such in all countries we weighted for sex \* age \* combined region, sex \* activity rate \* combined region, agricultural sector \* combined region, basic region (NUTS II or equivalent), urbanisation level, respondent occupation, marital status were introduced in the iteration procedure. For all weighting (national and for EU averages), INRA (EUROPE) applies the official population figures as published by EUROSTAT - Regional Statistics (1994) or national CENSUS data. The total population figures for input in the post-weighting procedure are listed above.

Readers are reminded that survey results are estimations, the accuracy of which, everything being equal, rests upon the sample size and upon the observed percentage. The real percentages vary within the following confidence limits :
